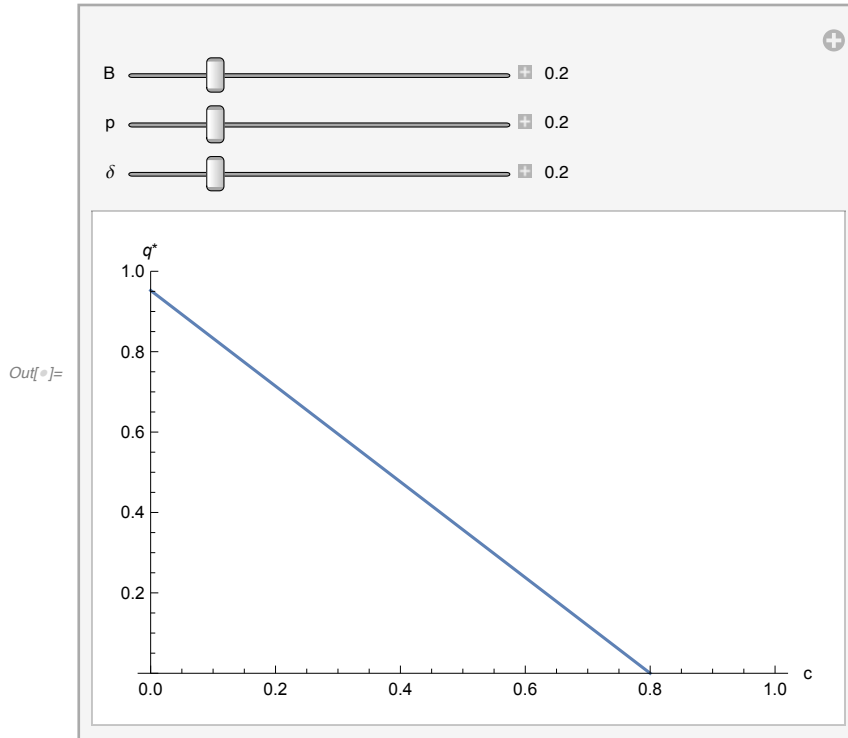

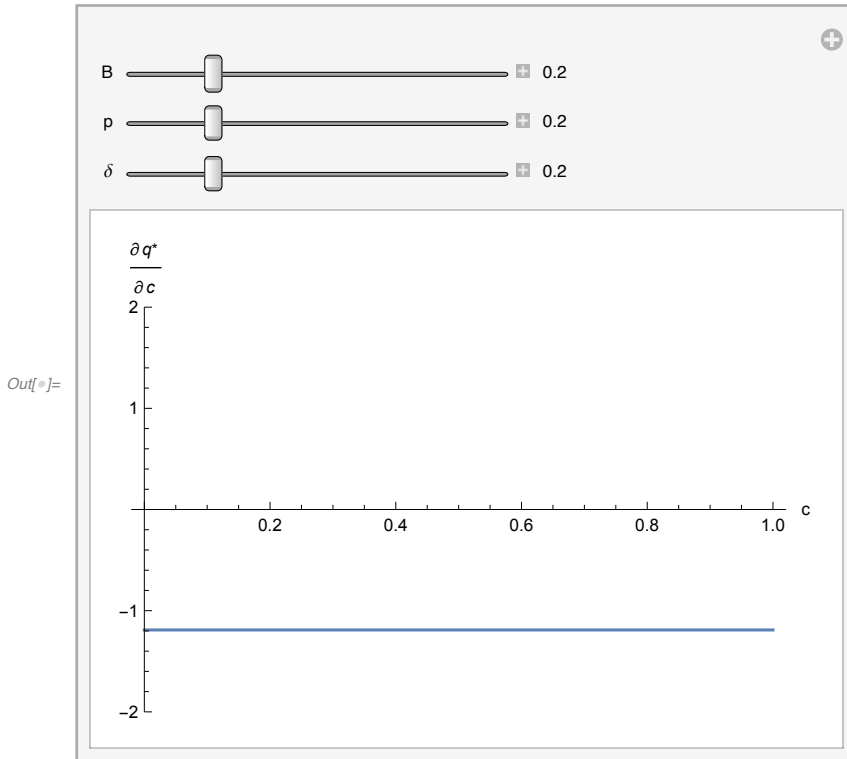

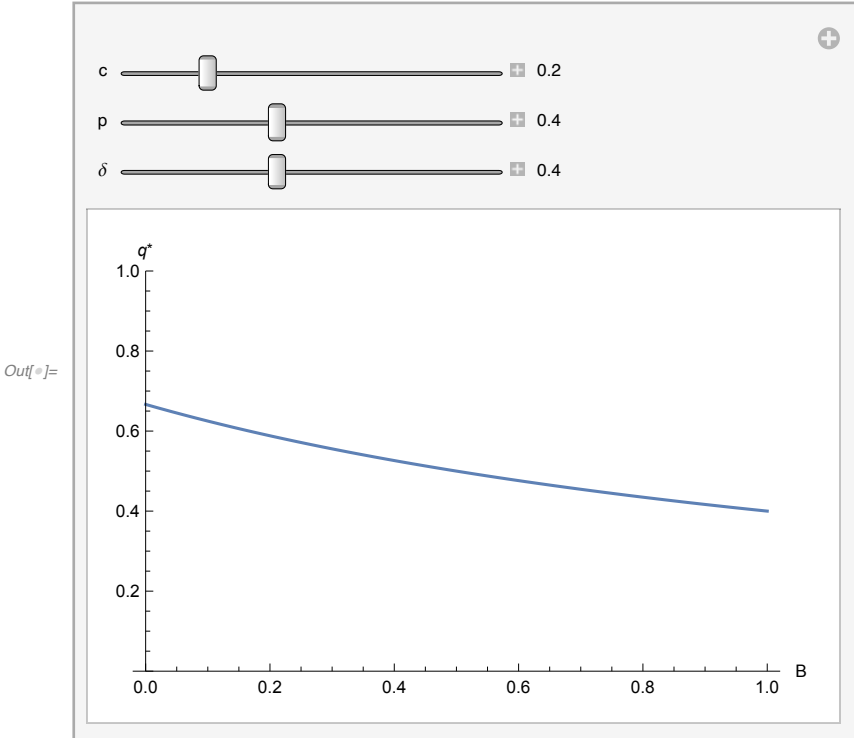

As B increases, q^* decreases at a non-linear rate with all other parameters held constant. The y intercept decreases for higher values of c and δ . The graph becomes linear and parallel to the x axis when $p=0$, since B and p are expressed as a product in the equilibrium expression and becomes non-linear and decreases for higher values of p

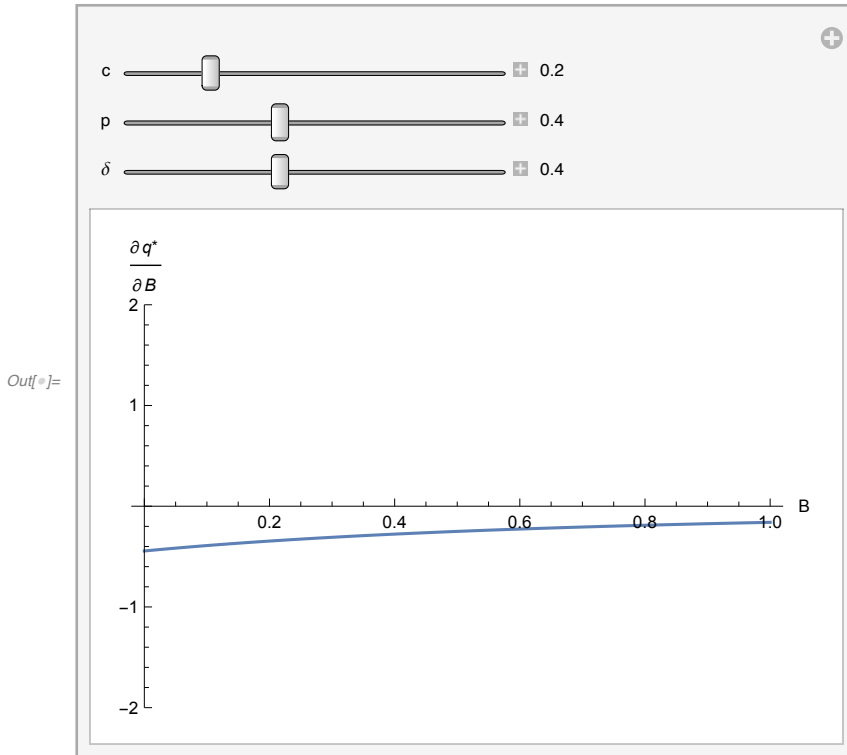

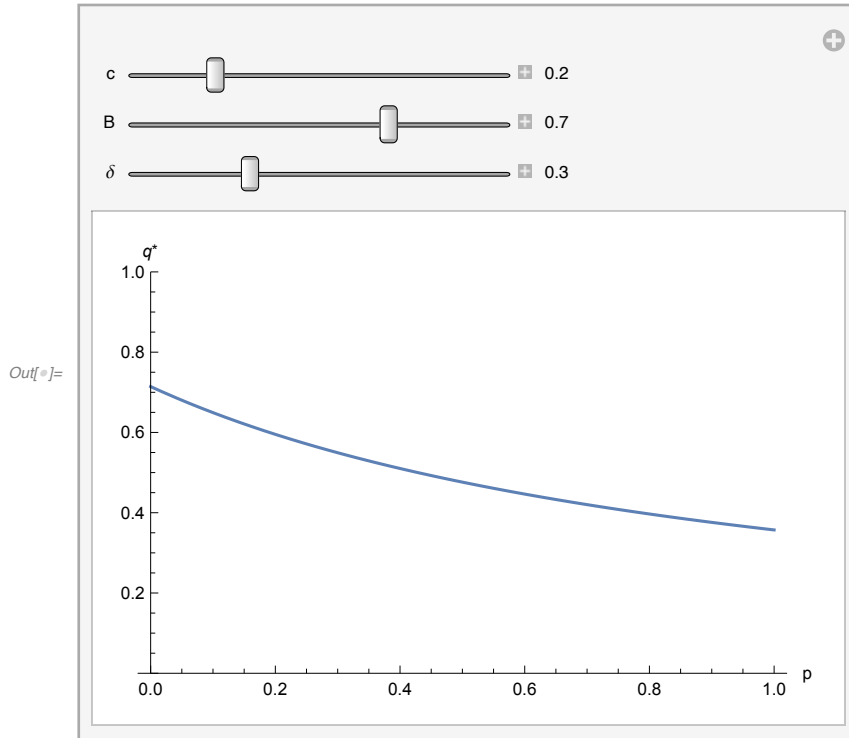
This shows that the rate of change of q^* with respect to B is negative and non-linear (increasing).

As p increases, q^* decreases at a non-linear rate with all other parameters held constant. The y intercept decreases for higher values of c and δ . The graph becomes linear and parallel to the x axis when $B=0$, since B and p are expressed as a product in the equilibrium expression, and becomes non-linear and decreases for higher values of B .

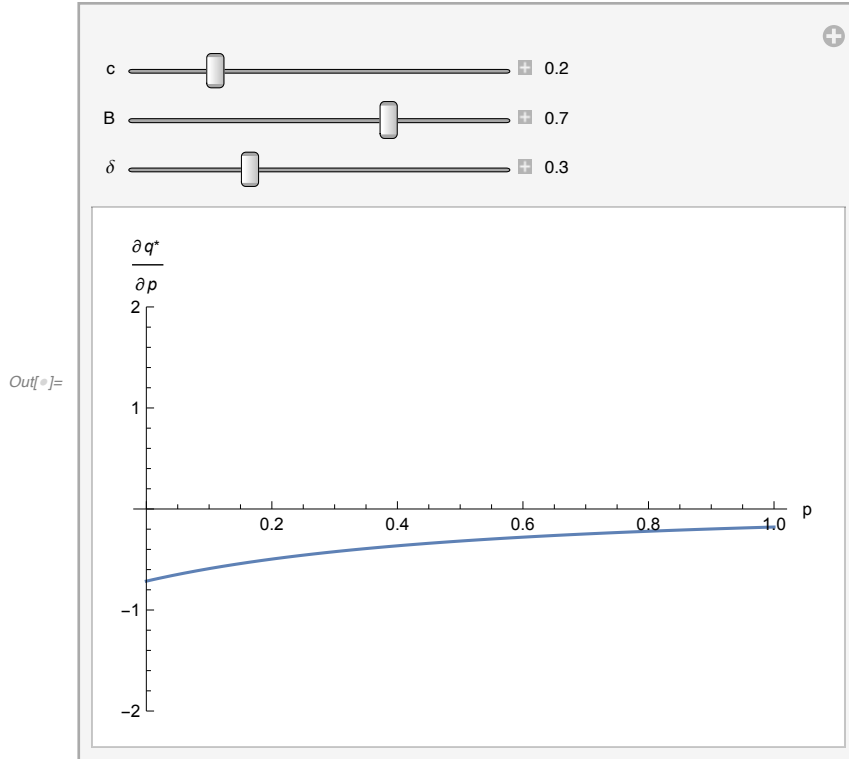

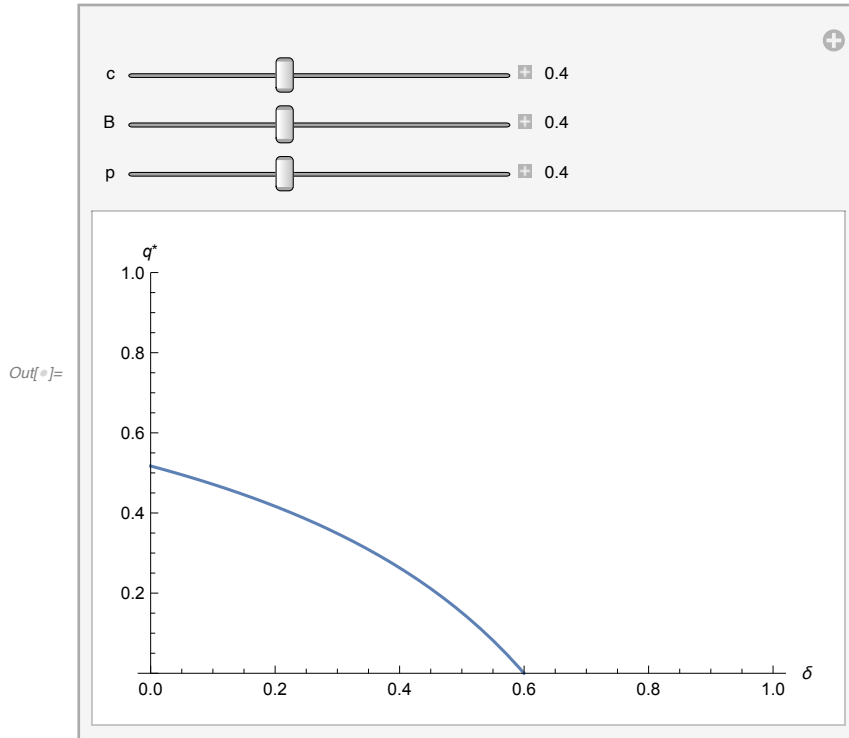
This shows that the rate of change of q^* with respect to p is negative and non-linear (increasing).

As δ increases, q^* decreases at a non-linear rate with all other parameters held constant. The y intercept and x intercept is lower for higher values of c . The y-intercept is lower for higher values of B and p , causing the curvature of the graph to become lesser as well.

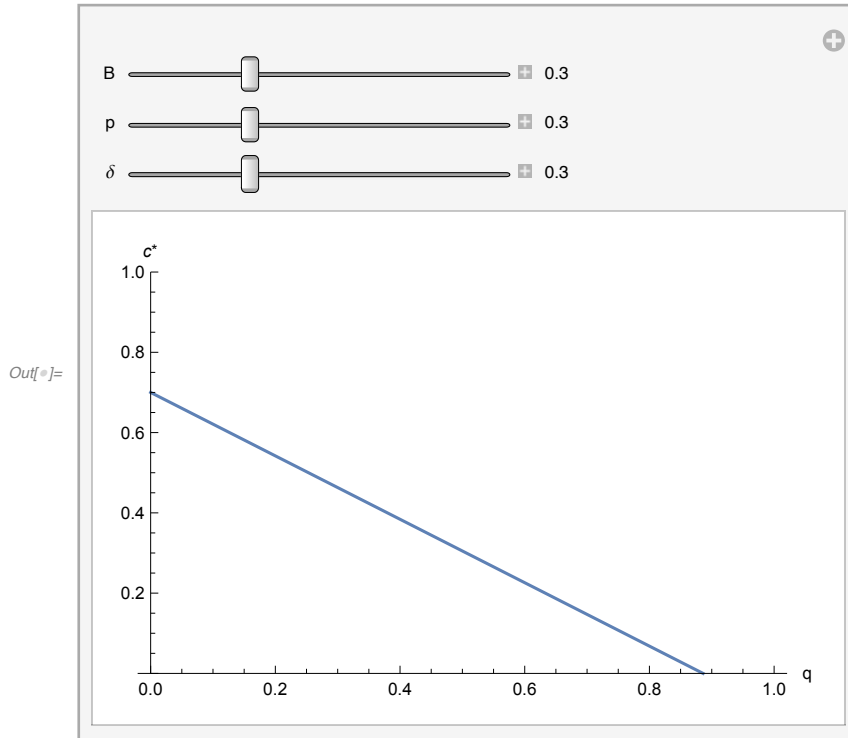

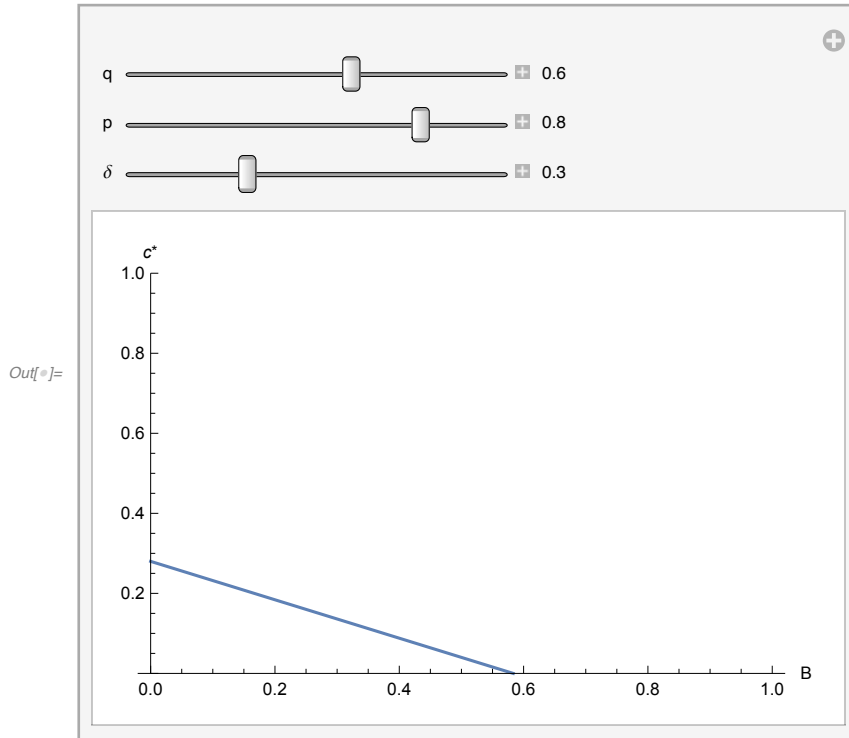

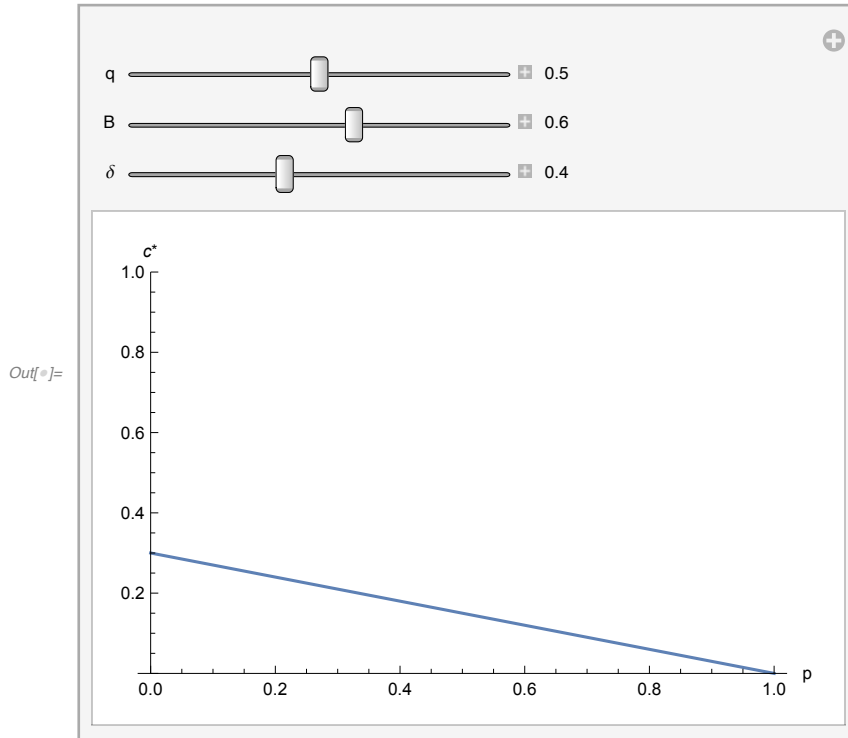

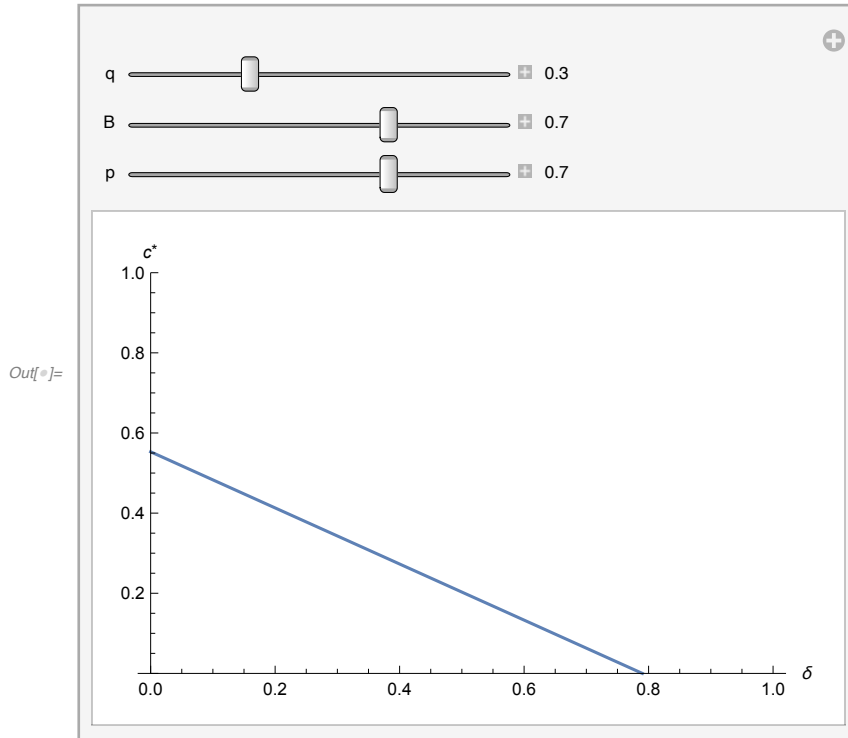

Graph Probability of Demand Rejection against q

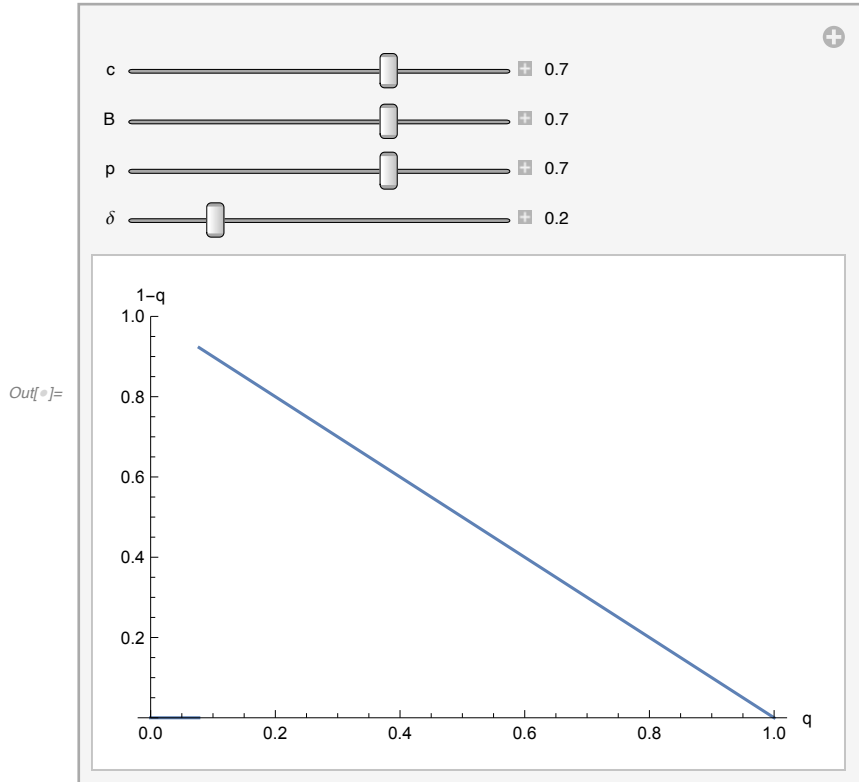

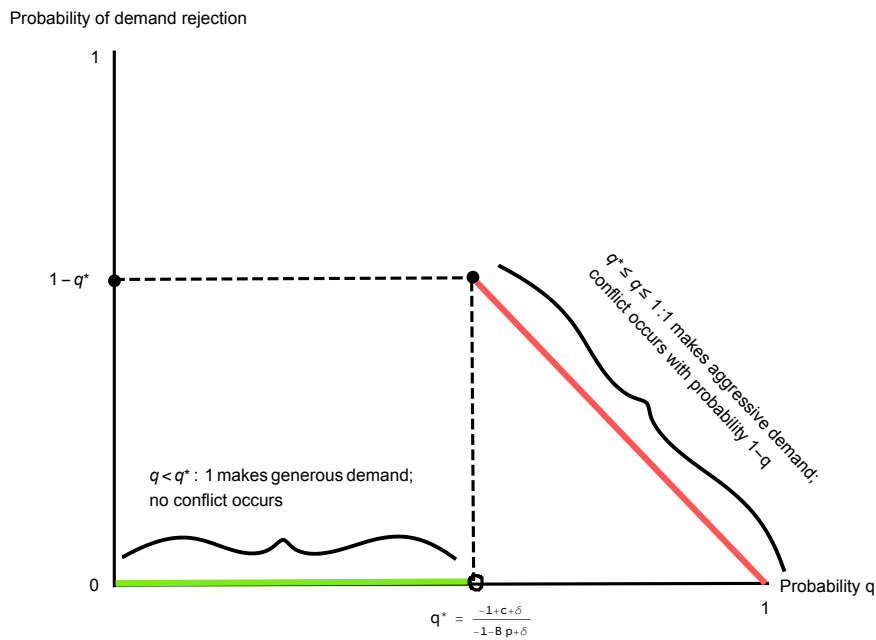

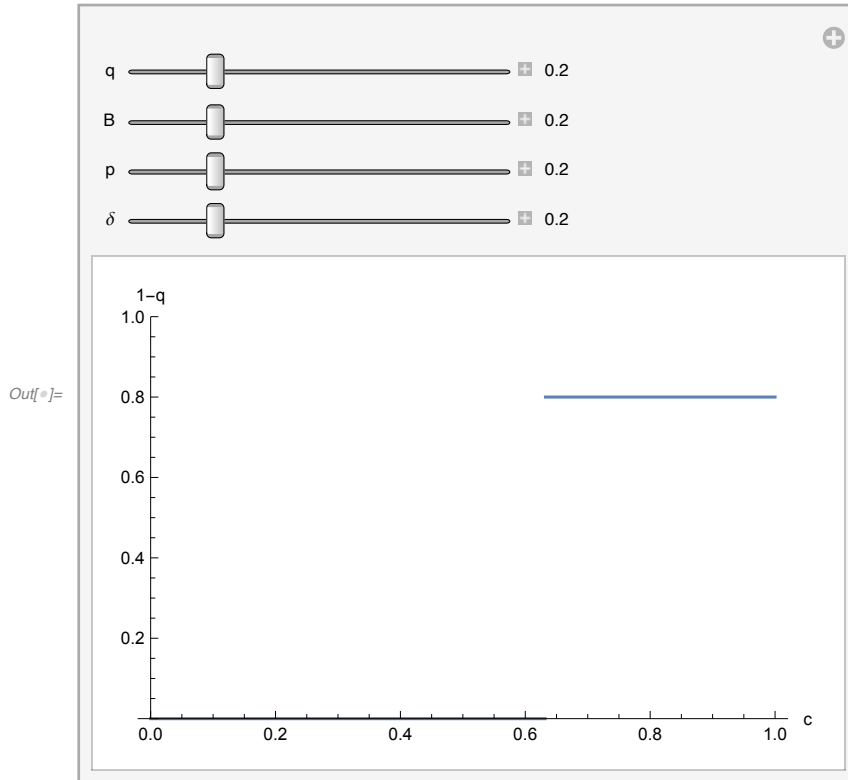

Graph Probability of Demand Rejection against c

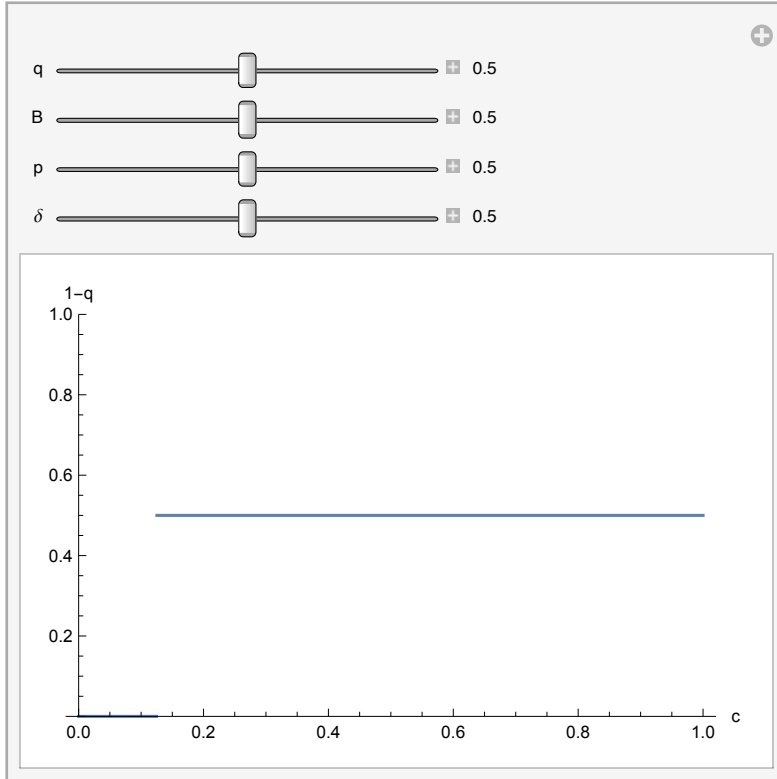

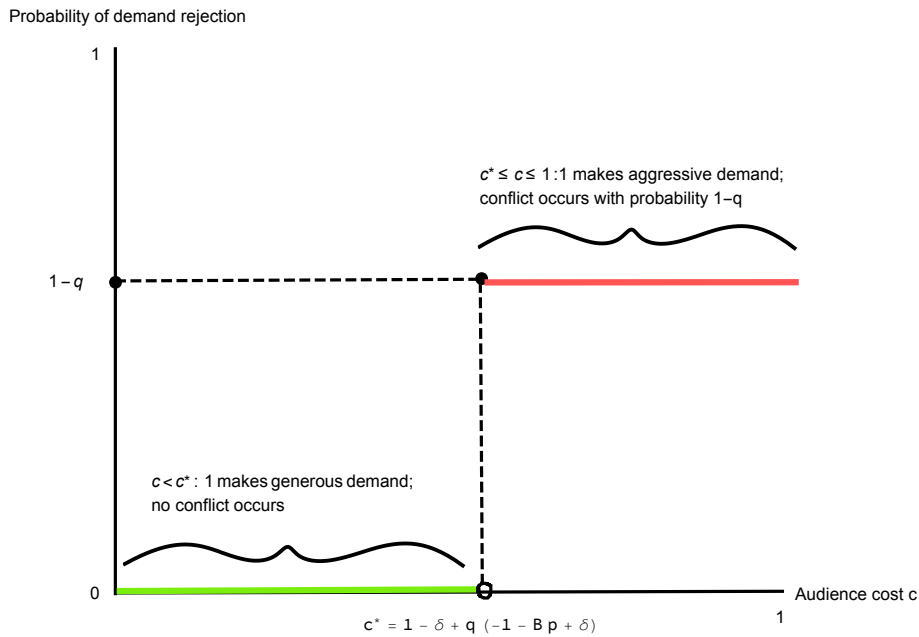

This shows that the equilibrium q^* is lower for medium values of c , B , p , and δ . If the values are higher, the piecewise function disappears and only the constant linear graph remains.



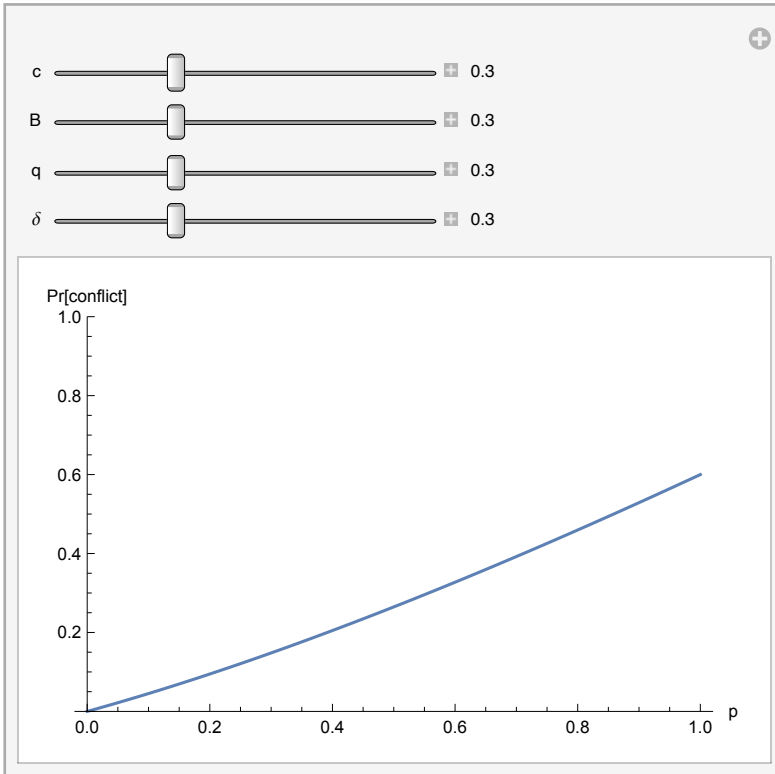

Probability of conflict i.e. demand rejection and terrorist attack is $p(1-q)$. For both lower and higher values of the parameters, as p increases, the probability of conflict also increases. This is not trivial because p is directly proportional to $p(1-q)$.
