In accordance with the provisions of section 301(d) of the Public Health Service Act 42 U.S.C. 241(d), this Certificate is issued in response to the request of the Principal Investigator, Dr. Drenna Waldrop-Valverde, to protect the privacy of research subjects by withholding their identities from all persons not connected with this research. Dr. Drenna Waldrop-Valverde is primarily responsible for the conduct of this research, which is funded by the National Institute of Nursing Research grant number 1F31NR015975-01A1.

Under the authority vested in the Secretary of Health and Human Services by section 301(d), all persons who:

- 1. are enrolled in, employed by, or associated with the Emory University and its contractors or cooperating agencies, and
- have in the course of their employment or association access to information that would identify individuals, who are the subjects of the research, pertaining to the project known as "Social Isolation and Retention in Care among Older Adults Living with HIV/AIDS (SOLO) Study)."
- 3. are hereby authorized to protect the privacy of the individuals, who are the subjects of that research, by withholding their names and other identifying characteristics from all persons not connected with the conduct of that research.

This behavioral research study examines unique factors associated with perceived isolation and one possible mechanism by which social isolation affects retention in care in older adults living with HIV/AIDS (>=50 years old).

Approximately 140 older persons living with HIV/AIDS will be recruited as subjects and complete one-time assessment. After that, subjects' electronic medical chart will be reviewed to abstract data on retention in care (i.e., adherence to clinic appointments) 12-month post one-time assessment.

A Certificate of Confidentiality is needed because sensitive information will be collected during the course of the study. The certificate will help researchers avoid involuntary disclosure that could expose subjects or their families to adverse economic, legal, psychological and social consequences.

Although all study related documents will only be labeled with a unique study participant code number that does not contain any identifying information, this study will be required to link the participant code to personal identifiers. This is due to the need to perform the prospective analysis on retention in care via medical chart abstraction. A linkage document will be maintained on the shared drives of the School of Nursing (secured/encrypted).

The shared drive of the School of Nursing contains folders for each faculty/doctoral students. These folders are inaccessible to anyone other than the "owner" of the folder who accesses the drive via password protection. After the study reaches completion and findings have been disseminated, all the identifiers will be destroyed.

This research begins on 7/11/2016, and is expected to end on 05/31/2019.

As provided in section 301 (d) of the Public Health Service Act 42 U.S.C. 241(d):

"Persons so authorized to protect the privacy of such individuals may not be compelled in any Federal, State, or local civil, criminal, administrative, legislative, or other proceedings to identify such individuals."
